

**Records of Auchtergaven/Auchtergaven East/Auchtergaven and Moneydie Kirk Session
1740-2005**

Auchtergave was originally within the jurisdiction of Dunkeld Presbytery until the mid-twentieth century when it was within the jurisdiction of Perth Presbytery. Ministry began within the session in 1567 in the person of Thomas Robertson (alias McGibbon). Auchtergaven kirk session united with Logie-Bride in 1618. That union was severed in 1632 and re-established in 1647. On 28 July 1931 the session united with the former United Free Church congregation of Auchtergaven South, taking the name of Auchtergaven East Church of Scotland. A further union occurred on 7 January 1979 with Moneydie to form the session of Auchtergaven and Moneydie Church of Scotland.
